Upon acceptance of the application, it is recommended that you begin the Botulism vaccine series prior to your horse's arrival in order to minimize the quarantine period.

RETIREMENT HORSE BOARDING APPLICATION

The complete care boarding fee is \$225.00 per month. This fee includes the following: 24/7 field board with shelter provided by sheds, hay in winter, staff attention, hoof trims, annual dental float, fall vaccinations, spring vaccinations, and parasite control. This does not include emergency veterinary care or supplemental feed. The first month of board shall be paid upon execution of the Boarding Agreement and prior to your horse's arrival to our facility. The monthly boarding fee must be received by the 5th day of each month and may be paid by check or credit card.

I, the undersigned, grant the staff of Long Branch Historic House & Farm, the authority to contact the references/vet/boarding facilities listed on this application. I understand that the information provided in this application will not be released to any outside persons or entities unless required by law.

I further understand that this is not the boarding agreement, but an application for consideration of this horse into the retirement boarding program. In signing, I hereby attest that the information provided in this application is true to the best of my knowledge.

Additionally, I understand that all fees incurred while boarding my horse must be paid in full prior to the horse's departure from Long Branch Historic House & Farm.
